# **Message from the Executive Director**



**Dear Friends and Families,** 

Thank you for supporting Children's Educational Opportunity Foundation of Connecticut (CEO) through your generous monetary donations, in-kind donations, and time dedicated to our scholars. **For 28 years**, CEO has provided children of low-income families with tuition assistance in grades K-8, working to expand educational opportunities across Connecticut. Thanks to your contributions, CEO is proud to have awarded **368 scholarships** to highly qualified, traditionally underserved students in 2022-2023.

The past year has brought about exciting changes for the organization, including the appointment of Hannah DeBruler as Program Manager to focus on deepening existing relationships with our schools and scholars, managing our application process, and **helping families find perfect-fit schools for their children**. Hannah's prior experience includes a focus on federal policies that affect educational freedom of Christian K-12 schools. And because she has personally benefited from attending a private K-12 school, she is passionate about giving back to the institutions that shaped her throughout her life.

Since my appointment to Executive Director of CEO in July, my focus has been on **prioritizing fundraising** and **developing a comprehensive strategic plan**. To that end, the Board of Directors and I have drafted a multi-year Vision that outlines our commitment to meeting and exceeding CEO's goals of increasing the financial resources necessary: to continue to fulfill the needs of our current scholars as well as to allow CEO to award scholarships to the growing number of children in need across Connecticut.

Since its founding, CEO has proudly awarded more than \$22 million to over 10,000 children, but more children need our help. Over the past year, donors funded scholarships for 368 qualified students, yet 222 students were guided to reapply in the future as funds were not available. With this in mind, I am pleased to announce our largest fundraising campaign to date. In one of our early conversations, Founder and current Board Chair, Dr. Lew Andrews shared that what keeps him up at night "are those children who are waiting for their turn for scholarship funding to reach them." Over the next year and beyond, our campaign will ensure that all qualified children receive the funding they need.

During the 2023-2024 school year, the Children's Educational Opportunity Foundation will count on some \$521,000 in donations to support Annual Giving. These funds for scholarships preserve the mission of CEO: to give the children of Connecticut equal access to quality education that best meets the needs of each child. Your generosity is our chance to strengthen our state for generations to come. I am humbled and energized by the Children's Educational Opportunity Foundation's impact on the children of Connecticut and am honored to lead this remarkable organization at this pivotal time.

Donors to CEO tell me that they want **the best education for all of Connecticut's children**. They believe all children should have the option to learn in a school setting where they can thrive, and that learning is about teachers unlocking the intrinsic abilities of every child. Above all, CEO donors understand that **shaping the future** in which we all wish to live starts with education.

### **ABOUT US:**

We believe the key to assisting children to grow into successful adults is a strong foundational K-8 education, regardless of their ability to pay.

We are an independent scholarship organization. Our focus is on helping children and their families - and what's best for them. We encourage parents and guardians to choose any accredited K-8 private or parochial school in Connecticut that will accept their student and work with CEO to apply our scholarship dollars to the child's tuition account each year. Our scholars have attended over 40 schools.

### THE CHALLENGE:

The number of applications CEO receives each year are often more than twice the number of available CEO scholarships/funds.

# WHAT WE DO AND WHO WE HELP

- Connecticut parents seek out CEO's assistance because they want a better life for their children. Parents understand the need for their children to attend the K-8 school that best meets the need and ability of their children.
- CEO provides equal access to K-8 accredited private schools by awarding one-half tuition up to a maximum of \$2,100 each year. Parents are responsible for the remaining tuition.
- Parents/guardians who are residents of Connecticut qualify if their income level is verified at or within 200% of the Federal Poverty Level for the size of their family.
- All of Connecticut's children deserve access to quality education. Together with generous donors, we provide K-8 tuition assistance to families in need.


