**\*Applications not accompanied by the required proof of income and residence will not be processed until satisfactory documentation is provided.**

Completed applications will be considered on a FIRST-COME / FIRST-SERVED basis. Applications will be posted on [www.ceoct.org](http://www.ceoct.org) on 3/1/2017.

**IF A CEO SCHOLARSHIP IS AWARDED:** CEO will notify you in writing if you are awarded a scholarship. Scholarship awards are calculated at one-half of the actual annual tuition up to a maximum annual award of \$2100 per student. Awards are paid directly to the private school chosen by the parent/guardian.
